POSITION RESPONSIBILITIES:

The Site Operations Manager's job responsibilities shall include, but not be limited to, the following:

- Have a thorough and complete knowledge and understanding of the contract drawings, specifications, and addenda.
- Assist in pre-construction activities including estimating, budgeting, bidding, and scheduling.
- Develop, implement, revise and distribute detailed construction schedules in coordination with the Contractors.
- Coordinate with survey firm to resolve issues on-site plans, existing conditions, topographical issues, and final as-built drawings.
- Ensure Contractor compliance with all aspects of the contract agreement.
- Coordinate and review shop drawings in accordance with the plans, specifications, and other contract documents.
- Review Contractor's and Consultant's Daily Reports.
- Conduct weekly coordination meetings with the Contractors and issue minutes to all applicable parties.
- Resolve field coordination issues.
- Experience in reading plans/blueprints, stakes, ability to check grades, understanding of soil types and composition, calculating slopes, percentages, and elevations, knowledge of the safe operation of the various types of equipment on the project.
- Review and approve Contractor and Consultant requests for payments.



- Prepare and log Change Order Requests and Change Orders.
- Track and coordinate compliance with all project permits.
- Utilize available construction management and accounting software to analyze job costs and update projected costs to complete.
- Coordinate and execute all documents required to properly close out a project's completion including final inspections, deficiencies, and warranty work.
- Participate fully in health, safety, quality, and environmental processes.
- Act with honesty and integrity at all times.
